



Waste Import Supplement Instructions

Introduction

This guidance document was prepared to assist customers in completing the US Ecology (USE) Waste Import Supplement. The Waste Import Supplement provides US Ecology the necessary information to compliantly import waste from outside of the United States. In order to import hazardous waste into the United States, consent must be given by the EPA.

Thorough information on the form expedites the approval process. Section A - Foreign Generator Information:

Foreign Generator Information	Foreign generator information should be representative of where the waste originated.

Section C- EPA Consent Information:

EPA Notice ID and EPA Consent Number	Complete only if a consent letter has been issued by the US EPA. Also attach a copy of the consent letter. Enter "NA" if not applicable
Effective Date, Expiration Date, Approved Volume	Complete only if a consent letter has been issued by the US EPA. Include effective date, expiration date and approved volume per the consent.

Section D- Company Assuming Importer Duties:

Importer Company Information	The U.S. importer must assume responsibility for the waste. The U.S. importer must have an address in the U.S., a US EPA ID number and must sign the Certification Statement. Note: Customers in Texas must have a Texas issued EPA ID number.
