

Land Disposal Restriction Form Instructions

Introduction

This guidance document was prepared to assist customers in completing US Ecology’s Land Disposal Restriction Form (LDR). The Waste/Material Profile Form (WMPF), LDR, and its supplements provide the necessary information to safely and compliantly manage our customer’s waste/material. Completing all documents thoroughly aids in expediting the approval process. A current copy of the WMPF and LDR is available on US Ecology’s website (www.usecology.com).

Generator Information

| 1 | ➤ Provide the generator’s name. |
| 2 | ➤ Provide the generator’s EPA ID Number, if applicable. |
| 3 | ➤ Provide the manifest number from the shipping paperwork. |
| 4 | ➤ Provide the line number from the shipping paperwork. |
| 5 | ➤ Indicate if the waste is a Wastewater per 40CFR part 268.2(f), Non-Wastewater per 40CFR part 268.2(d), or debris per 40CFR part 268.2(g). This should match the response to question G3 on the WMPF. |
| 6 | ➤ Indicate the notification frequency of the LDR. A one time LDR notification is permitted per 40CFR part 268.7(2) and throughout the remaining portions of that section. Certain situations, such as lab packs, may require the LDR sent with each shipment. |
| 7 | ➤ Indicate the RCRA waste codes for the shipment. This should match those entered for question E3 of the WMPF. |
| 8 | ➤ Indicate if Underlying Hazardous Constituents (UHCs) will apply per 40CFR part 268.48. If yes, please list the applicable constituents from the table. This should match the response to question E6 on the WMPF. |
| 9 | ➤ Indicate if a subcategory will apply per the table in 40CFR part 268.40. If yes, select the applicable subcategory from the drop-down menu available. This should match the response to question G4 on the WMPF. |
| 10 | ➤ Indicate if the waste contains constituents requiring treatment in F001-F005, F039, debris, or alternate soils. If yes, list the constituents. |

Requires Treatment

➤ Select the appropriate treatment option based on the selections made for questions G2 and G3 on the WMPF. As a reminder, G2 clarifies if the waste was treated after the initial point of generation. Question G3 requires a selection of Wastewater or Non-wastewater as well as a selection for alternative treatment standards for soil, debris, or indicating the waste meets LDR treatment standards. The 40CFR references are mentioned if further detail is needed.

Waste Meets Treatment Standards:

➤ Select the appropriate option for material already meeting treatment standards. This should be answered based on the selections made for question G3 on the WMPF. The 40 CFR references are mentioned if further detail is needed.

Certification:

➤ Complete the Name, Signature, Title, and Date fields.
